2. PEECAUTIONS

This camera is suitable for indoor operation only. Use the camera at temperatures within -40°C~60°C (-40°F~140°F) and humidity between 20% and 80%. This device is not rated as submersible. The input power source is 12VDC/24VAC regulated.

8. Mounting

Use care in selecting a solid mounting surface which will support the weight of the camera plus any wind, snow, ice or other loading, and securely attach the camera to the mounting surface using screws and anchors which will properly support the camera. If necessary (e.g. when mounting to drop ceilings) use a safety wire to provide additional support for the camera.

1. Firmly insert included drywall / concrete anchors.





2. Align the base plate holes and tighten all 3 screws





Image is too dim	<ul style="list-style-type: none">• Remove protective film• If window is dirty, clean the lens with soft clean cloth
Image flickers	<ul style="list-style-type: none">• Change the camera angle so the camera is not facing directly to the sunlight or fluorescent light
Contrast is too low	<ul style="list-style-type: none">• Adjust the contrast• Change the camera angle so the camera is not facing directly to the sunlight or fluorescent light
